प्रवेश रद्दकरण्याबाबतचे नियम

- 1) 5% of the total annual fees will be deducted/charged if the student cancels his/her admission within 7 days from the date of admission.

जर विद्यार्थ्यांनी प्रवेश घेतलेल्या दिनांकापासून ७ दिवसांच्या आत आपला प्रवेश रद्द केला तर एकूण वार्षिक शुल्काच्या 5% रक्कम कपात करण्यात येईल.

- 2) 10% of the total annual fees will be deducted/charged if the student cancels his/her admission within 14 days from the date of admission.

प्रवेश घेतलेल्या दिनांकापासून १४ दिवसात जर विद्यार्थ्यांनी आपला प्रवेश रद्द केला तर एकूण वार्षिक शुल्काच्या 10% रक्कम कपात करण्यात येईल.

- 3) 100% of the total annual fees will be charged if the student cancels his/her admission after 14 days from the date of admission.

प्रवेश घेतलेल्या दिनांकापासून १४ दिवसानंतर जर विद्यार्थ्यांनी आपला प्रवेश रद्द केला तर एकूण वार्षिक शुल्काच्या 100% रक्कम विद्यार्थ्यांकडून वसूल करण्यात येईल.

- 4) जे विद्यार्थी (द्वितीय व तृतीय वर्ष प्रवेशास पात्र असतील) PASS/ATKT/F-ATKT असतील आशा विद्यार्थ्यांना आपला प्रवेश रद्द करावयाचा असल्यास महाविद्यालय सोडतांना त्यांना पुढील वर्षाचे पूर्ण शुल्क भरावे लागेल याची सर्वांनीच नोंद घ्यावी.

Note:- Cancellation of admission for second and Third Year for all course of SSBES' ITM.

Please read the following rules carefully:

Those eligible candidates having passed clearly with PASS/ATKT/F-ATKET in the preceeding year may cancel their admission of higher classes if needed, if and only if the full fees of the succeeding year for which they are eligible since the seat will remain vacant. For example, First Year PASS/ATKT/F-ATKT students wish to cancel their Second year admission then they will have to pay the full fees of second year also. Likewise, Second year PASS/ATKT/F-ATKT Students wish to cancel their Third year admission then they will have to pay the full fees of Third year. This is applicable for all courses as well.
