## 1. PREAMBLE

- iii. Any other activity not covered by this MOU with the prior agreement of both institutes.
- iv. During the MOU the institute should not collaborate with any other agencies or organizations on the same theme, as it will be conflict of interest.

#### 4. Finance

The MOU is based on non - commercial basis. Shri Sharda Bhavan Education Society's Institute of Technology and Management, Nanded will take care of all hospitality on campus for physical training programs. Infrastructure and support towards conducting of sessions and webinars to be provided to Shri Sharda Bhavan Education Society's Institute of Technology and Management, Nanded

#### 5. IMPLEMENTATION AND ACTION PLAN

G - IC, Mumbai and Shri Sharda Bhavan Education Society's Institute of Technology and Management, Nanded shall endeavor to finalize the details of implementation and action plan of collaborative efforts to execute the parts of this MoU in the academic year to year basis.

This MoU shall be effective from the date of signing for 5 years and it may remain in effect for the subsequent year on perpetual basis and may be discontinued thereafter by mutual consent.
