Functions of the Committee

5. Maintain proper records of grievances received, proceedings conducted, and actions taken.
6. Submit periodic reports on grievance redressal activities to the Head of the Institution.

The Committee shall function in accordance with the applicable **UGC, AICTE, and University** guidelines. The tenure of the Committee shall be **two years** or until further orders, whichever is earlier.
