In the event that either party wishes to disclose any data and/or information supplied in or resulted from the implementation of this MoU, the disclosing party shall have prior written consent from the other party.

12. Entry into Force, Duration and Termination


- 1) This MoU shall enter into force on the date of signing.

MEMORANDUM OF UNDERSTANDING (MOU)

- c) To establish the basic terms to be used in a future agreement between the Parties.

3. ROLES AND RESPONSIBILITIES OF PARTIES

Mutual understanding of the parties agreed and declared as follows:

3.1 ROLE OF DRTE Foundation

- a) Presenting opportunity to students to be part of Youth Ambassador Program (YAP) for Financial Literacy. To undertake orientation on importance of Financial Literacy, offer free course package designed by Tata Capital. On completion of the course, each student will receive a certificate of completion. Those students who complete the course will be trained to be Youth Ambassadors to spread awareness on financial literacy to the beneficiaries in need (Awareness for Students who have completed 7th Std, College students, Communities, Women, SHG).and 1 hr financial Literacy program for girls and all student for Energy Literacy Program and 3hr Completion Training and Certification and all other social activities
- b) Offer Internship programs for the students to build experience and internship completion certificates provided on successful completion of the Internship tenure.

- c) Invite and engage students and faculties in formal events, which DRTE may host.
- d) Provide an opportunity to selected students and faculties to be part of hybrid organization's Sumeet etc. workshops, events.
- e) Offer motivational, leadership, and personal development training for students that can be offered at nominal charges or free to the institution whenever needed.
- f) Offer SDG and ESG programs for students at nominal costs or free whenever needed.
- g) Provide volunteering opportunities for the students in the social sector if available.
- h) Help institution to promote sustainable development practices.

3.2 ROLE OF Institute of Technology and Management, Nanded

- a) Facilitate and support in organizing the projects, events, workshops, and competitions organized by DRTE
- b) Motivate students to participate in the programs and organize campaigns at college level, inter- college level and around the vicinity of college surroundings benefitting the communities.
- c) Appoint teacher coordinators and student leaders who shall be responsible for coordinating and undertaking activities in college.
- d) Provide venue and arrangements for organizing events, workshops for the above-mentioned program.
- e) Provide invitations to DRTE for events and programs, that is open for the partners.
- f) Provide space for branding and promotion for DRTE, as and when agreed upon during college events.
- g) Cost associated to the event/campaigns organized by the students, will be borne by institution.
- h) To motivate students for internship and volunteering (online or offline).

4. GENERAL TERMS OF MOU

4.1 BRANDING AND PUBLICITY GUIDELINES

Both Parties agree that there will be publicity opportunities to help multiple audiences better understand the issue associated with the MOU.

- (i) The same may be communicated and publicized to the relevant audience through events, conferences, workshops, meetings, advertisements, word of mouth, emails, social media etc. Towards the same communication materials may be built by either or both Parties to reach the target audience through videos, PPT, press releases as appropriate, fact sheets, and success stories. In all such communication, DRTE and Institute of Technology and Management collaboration will be duly acknowledged along with the use of their respective logos.
- (ii) Any use of data for research or any other project-related purpose by Institute of Technology and Management will be done with the agreement of DRTE Foundation with due acknowledgment of their role in the project.

4.2 CONFIDENTIALITY

Both Parties shall not (except in the ordinary course of responsibilities), during or after the period under this MOU, divulge to any person whatever or otherwise make use of any trade secret or any confidential information concerning this program, or finances of either Parties or any of its dealings, transactions or affairs or any trade secret or any such confidential information concerning any of the Parties or any of their suppliers, agents, distributors, or customers.

4.3 INDEMNIFICATION

Both the parties hereby jointly and severally agree and undertake to indemnify and keep all of its Affiliates, its directors, officers, representatives, and employees indemnified against any loss, claims, charges, liabilities, obligations, expenses including reasonable attorney fees and damages, incurred by either party, due to, relating to or arising out of any misrepresentation, act, or mission or commission caused by their/its employees/ staff, servants, agents, representatives of the terms and conditions of the MOU.

4.4 TIME PERIOD OF THE MOU

The MOU will be valid for 1 year from the signing date of both Parties. On mutual agreement, the MOU may be extended for a further period, by way of a written amendment to this MOU.

The terms of the MOU unless mutually terminated shall be from the effective date, i.e., the date of signing of the MOU by both Parties and up to a period of one (1) year and extendable as per the project requirements and as per the understanding and agreement between the Parties.

4.7 DISPUTE RESOLUTION

At the written request of either Party (which may be given by electronic mail), the Parties will attempt to resolve any dispute arising under or relating to this MOU through the appointment of a senior management representative (one each from both the Parties); hereinafter referred to as "Management Representatives", who does not devote substantially all of his or her time to performance under this MOU. These Management Representatives will furnish to each other all non-privileged information with respect to the dispute that the Parties believe to be appropriate and germane and will negotiate diligently and in good faith in an effort to resolve the dispute without the necessity of any formal proceeding. In case the dispute is not resolved within 60 days from the date of formation of this committee of Management Representatives, then the Matter shall be subject to arbitration by a sole arbitrator mutually appointed by the Parties. In the event the Parties fail to agree upon a sole arbitrator, both Parties may approach the High Court for the appointment of an Arbitrator.

This MOU shall be governed and construed in accordance with the laws of India and the claims and disputes arising out of or in connection with this MOU would be adjudicated, to the exclusion of other courts, by the courts of Mumbai, India.

4.8 OTHER PROVISIONS AND TERMS

Both Parties agree that they shall not engage in (or authorize or permit any person or entity acting on its behalf to engage in) any corrupt, fraudulent, coercive, collusive, or obstructive practices with respect to the Project or any transaction contemplated by this MOU.

1. Background

- The **Shri Sharda Bhavan Education Society's Institute of Technology and Management, Nanded (SSBES' ITM)** was established in the year 1997 affiliated to Swami Ramanand Teerth Marathwada University, Nanded, and ever since then it has been a leading institute in the field of Technology and Management catering the needs of professional education in the Marathwada region of Maharashtra State. In the course of its glorious journey of over 26 years, The college offers 03 UG (BCA, BBA, B.Sc. (HS)) and 02 PG (MCA & MBA) programmes in addition to 1 PG programme (MBA) offered by the YCMOU Study Centre on the campus. Out of 24 Teaching Faculty members, 11 have been awarded Ph.D.. This institute has been included under the section of 2 (f) and 12 (b) of UGC Act 1956.
- Enpro Envirotech Pty Ltd, (EEPL) based in Adelaide, Australia provides innovative environmental solutions and services that help to reduce carbon footprint while achieving sustainability. Such solutions and services are related to water, wastewater, waste and energy.
- Through the increased facilitation and coordination, **SSBES' ITM** wishes to work with EEPL for sharing the knowledge about advanced solutions in an international market to students and work collaboratively with the staff.
- The purpose of this MOU is to establish exchange of experiences between **SSBES' ITM** and EEPL for the benefit of students and the staff.
- The two organizations shall cooperate in developing mutual interests on a reciprocal basis and respect for the independence and equal status of each organization.

2. Scope of MOU

This agreement details the terms & conditions, financial arrangements and modalities of collaboration that may involve intellectual property rights (IPR), and responsibilities and obligations of the **SSBES' ITM** and EEPL, pertaining to the

- (i) Training/projects undertaken by the students of **SSBES' ITM**
- (ii) Various courses offered by the **SSBES' ITM** at Diploma, UG, PG and PhD levels
- (iii) Work and develop new research projects that are relevant to the real-world problems

3. RESPONSIBILITIES OF SSBES' ITM & EEPL

- **SSBES' ITM** will inform **EEPL** from time to time about their potential requirements for knowledge sharing in the field of environmental, microbiology and biotechnology field.
- **EEPL** may formally depute its representative, whenever possible, to arrange special talks to a selected group of **SSBES' ITM** students.

- **EEPL** can arrange a visit of UG & PG students of the **SSBES' ITM** for industrial visits with further training on different topics after finalizing the schedule with prior permission of various industries/organization based in Adelaide. The overall charges can be decided based on duration, type of visits and training modules. With mutual consent and prior permission from and/or between the concerned institutes, students of the **SSBES' ITM** may be allowed to do projects (as part of their curriculum) and short-term courses, internship programs during summer or during semester-break in collaboration with **EEPL**.

- **EEPL** may organize seminar, workshop or conference at the **SSBES' ITM** campus. In such cases the **SSBES' ITM** will provide all the logistic support to the **EEPL**.

- Any other academic activities may be jointly organized by the **EEPL & SSBES' ITM** like co- hosting of workshops, seminars etc., after due consultation, assessment and mutual consent.

4. COOPERATION AGREEMENT

Cooperation between the Parties may include activities such as:

- The development of a strategic research action plan

- The identification of key priorities with the view to develop and submit research funding applications to different funding agencies and any other relevant opportunities

- Development of co-authored publications, communications and dissemination of research findings

- The identification of students to undertake short term projects and internships

- Student and staff visit to Australia for industry experience and training in identified areas

- Joint research projects of mutual interest in relation to the advancement of circular economy, resource recovery and environment management in general

- Joint activities, including seminars, conferences and public lectures

- Exchange of knowledge and information in identified areas

- Such other projects for mutual benefit that are agreed upon by both Parties

5. ACTIVITIES

- Any activities or arrangements including specific research collaboration projects that are intended to give rise to legally enforceable rights or obligations will be the subject of separate formal written agreement between the Parties.
- Collaborative activities may include but not limited to development of projects that value add, enhance or promote student and university well-being, sustainability and community engagement and management, including adapting and responding to future challenges such as climate change, food security, and migration/population development.

6. FORCE MAJEURE

Neither the **SSBES' ITM** nor **EEPL** shall be held responsible for non-fulfillment of their respective obligations under this agreement, due to the exigency of one or more of the force majeure events such as but not limited to acts of God, war, flood, earthquakes, strikes, lockouts, epidemics, riots, civil commotions etc., provided on the occurrence and cessation of any such event the parties affected thereby, shall give a notice in writing to the other party within one month of such occurrence or cessation. If the force majeure continues beyond six months, the parties shall jointly decide about the future course of action.

7. TERMINATION OF AGREEMENT

This agreement may be terminated by either of the parties forthwith if either of them commits breach of any of the terms hereof and shall have failed to rectify such breach within thirty days of the notice in this behalf having been served on it by the other party i.e. either **SSBES' ITM** or **EEPL** in correspondence; as the case may be. In addition to the above reasons, this agreement may be terminated forthwith if either of the parties voluntarily or involuntarily enters into official dilution, bankruptcy or similar recognizable proceedings or if, applications invoking such proceedings have been filed.

8. DURATION

This 'Memorandum of Understanding' shall remain valid for a period of five years from the date of signing of the MOU. After this, the MOU may be terminated or may be renewed after judging the then situation.

9. SETTLEMENTS

Upon termination of the agreement: All rights granted to **EEPL** and The **SSBES' ITM** hereto, shall cease to exist forthwith; except the obligation of The **SSBES' ITM** to keep collaborative activity in confidence, accrued on or prior to the date of such termination, make written reports and keep records, files and books, and the right of **EEPL** to inspect the same.

10. AMENDMENTS TO THE AGREEMENT

No amendment or modification of this MOU shall be valid unless the same is made in writing by either the parties or their authorized representatives, specifically stating

the amendment to this MOU. The modifications /changes shall be effective from the date on which they are executed; unless otherwise agreed to. In general, the MOU will be amended on yearly basis, if required, on mutually agreed terms.

11. ASSIGNMENT OF THE AGREEMENT


The rights and/or liabilities of this MOU shall not be assigned except with the written consent of The **SSBES' ITM** and **EEPL**, subject to such terms and conditions, as may be mutually agreed upon, by both the parties.

The details of this agreement are to be decided by mutual consultation between the two parties. Both parties understand that all terms and conditions of the above-mentioned activities as well as financial arrangements will have to be negotiated and established in separate written agreements.
